- 9. That this Memorandum of Understanding is valid up to 06.06.2025s.
- 10. The College can provide Students only but the college will not take any financial responsibility.
- 11. That Right Brains Technology will be entitled only to 90% of the registration fee from the College for the provision and maintenance of the said amenity.
