THIS MEMORANDUM OF UNDERSTANDING (MoU) is entered on this ...¹⁵... day of ~~November~~ 2023 (Two Thousand Twenty-Three), at Kolkata, by and between:

Ramakrishna Mission Swami Vivekananda's Ancestral House and Cultural Centre, 105 Vivekananda Road, Kolkata, West Bengal 700 006, (a branch centre of the Ramakrishna Mission, [a Society, registered under the Societies Registration Act, 1860, presently governed by the West Bengal Societies Registration Act, 1961 (Act XXVI of 1961), bearing Registration Number 1917/3 of 1909-10, (New Digitized e-Registration No. S0916370), having its registered office and headquarters at P.O Belur Math, District Howrah, P.S. Bally, West Bengal 711202]), represented herein by **Swami Jnanalokananda**, Secretary of the said Ramakrishna Mission Swami Vivekananda's Ancestral House and Cultural Centre, Kolkata, hereinafter referred to as the "**Centre**", (which expression shall, unless it be repugnant to the subject or context thereof, shall deem to mean and include its successors and assigns) of the **ONE PART**;

AND

Berhampore Girls' College, P.O. Berhampore, District Murshidabad, West Bengal 742101, represented herein by **Dr. Hena Sinha**, Principal of the said Berhampore **Girls' College**, Berhampore, Murshidabad, hereinafter referred to as the "**College**", (which expression shall, unless it be repugnant to the subject or context thereof, shall deem to mean and include its successors and assigns) of the **OTHER PART**.

Centre and College are hereinafter individually referred to as a "Party" and collectively as the "Parties" as the context may require.

The Parties hereby enter into this MoU to collaboratively conduct **certificate course** on "**Value Education**" for the students of the College.

The Parties hereby do agree that the objective of the course is to bring about a holistic development and moral edification of the students. By rekindling and instilling eternal moral values in the students, the course aims to nurture their innate goodness and infuse confidence in them.

To fulfill this objective, the parties of this agreement and witnesses thereof agree on the following matters:

- **Curriculum:** The curriculum of this course shall be based on the text: "**Mulya Bodhe Dhanya Jibon**", authored by Swami Jnanalokananda, Ramakrishna Mission Swami Vivekananda's Ancestral House and Cultural Centre, Kolkata-700006.
- **Resource Person:** The panel of resource persons shall be decided before commencement of the course on the advice of Swami Jnanalokananda.

- **Platform:** The course shall be conducted in a virtual or physical platform in accordance with the prevalent government guidelines.
 - **Infrastructure:** The infrastructure for conducting the course shall be arranged by the college.
 - **Schedule:** The schedule shall be decided by the Principal of the College or any person authorized by her, in consultation with Swami Jnanalokananda.
 - **Study materials:** Study materials shall be provided to the students by the College.
 - **Evaluation:** A continuous evaluation assessment shall be conducted by the College in consultation with Swami Jnanalokananda or any other person authorized by him.
- Certificate:** At the end of the course, certificate shall be issued to the participants jointly by both the institutes.
- **Period of MoU:** The agreement for conducting the course shall remain in force for a period of five (5) years from the date of signing and maybe renewed for a further period on mutual agreement.
